- b. Copyright & Personal Information Agreements Recent D.A.S.H. meeting expressed concerns re copyright infringement issues. John felt that he did not have the expertise required to comment on Copyright issue

To the Board of Springwater Sports

Hall of Fame— December 4, 2013

Openning; Gary Edgecombe

Issue: Best possible structure for this organization

Common Solution; Not for Profit Corporation without share capital

Advantages – no income tax returns

- inexpensive to manage

- is recognized a an independent legal entity

- may be eligible for CRA charity designation

- Can insure executive for personal liability

Examples where this type of corporation is used; Elmvale Curling Club

Elmvale Figure Skating Club

Elmvale Minor Hockey

Significance for these organizations: The ability to insure personal liability of their directors and officers. And, each of these organizations has inherent risks in their ventures, the curling club with alcohol sales and the hockey and skating club with physical injuries.

SUGGESTION That the common form of non-profit incorporation isn't necessarily the most viable alternative for you This organization is exceptional low risk for liability, so that shouldn't be of concern

But I see a very significant difference between this and the aforementioned groups. Each of the

tthis board, and the hall of fame, will not generate membership for specially interested people.

THUS, I believe your main concern should be sustainability in the future for this organization.

SUGGESTION: I think this board should investigate a partnership type relationship with the Township of Springwater, possibly modelled, to a smaller degree, along the lines of the Library

The Township can accept donations

The Township is self perpetuating and, under that umbrela, I think the Sports hall of Fame could flourish for many years
